AN ORDINANCE CONCURRENTLY DEANNEXING CERTAIN ABUTTING LANDS AT THE SOUTHEAST CORNER OF ARGO ROAD AND 7 HWY WITH THE CITY OF BLUE SPRINGS, MISSOURI, AND AUTHORIZING AND DIRECTING THE CITY CLERK TO DO THOSE THINGS NECESSARY TO ACCOMPLISH SAID ACTION.

WHEREAS, the cities of Independence and Blue Springs having abutting boundaries do desire to concurrently detach certain lands from one community and annex the same lands by the other community for the mutual benefit of both municipalities; and,

WHEREAS, a procedure has been established pursuant to Section 71.011 R.S.Mo. to accomplish said exchange of lands between adjacent municipalities; and,

WHEREAS, there are no residents living in the area proposed to be concurrently detached and annexed as set forth herein; and,

WHEREAS, the property owners, Mary Jo Falco and Joseph L. Falco, have requested the transfer of land between the municipalities so that the property can be developed under a singular set of Codes and Ordinances to help make the development process clearer and less burdensome; and

WHEREAS, the City Council deems it to be in the best interests of the City of Independence, Missouri, to effectuate the exchange of lands between Independence and Blue Springs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

<u>SECTION 1.</u> That the lands described in Exhibit A, attached hereto, incorporated by reference thereto and made a part hereof as though fully set out herein, are hereby deannexed from the City Limits of the City of Independence, Missouri, and are concurrently attached into the City of Blue Springs, Missouri.

<u>SECTION 2.</u> That the reasons for and the purposes of the concurrent annexation and detachment by and between the cities of Independence and Blue Springs, Missouri, are to facilitate development of the property by reason of it currently being in multiple cities and development is deterred due to the multiple jurisdictions and further by reason that once developed delivery of services such as police, fire and street maintenance would be almost impossible unless merged into a single jurisdiction.

SECTION 3. That there are no residents living in the area described in Exhibit A and therefore there is no requirement for an election or declaratory judgement.

SECTION 4. That the City Clerk is hereby authorized and directed to file one certified copy of this ordinance with the Jackson County Clerk's office, one certified copy of this ordinance with the Jackson County Recorder of Deeds office and one certified copy of this ordinance with the Circuit Court of Jackson County. That the City Clerk is further authorized and directed to take any and all necessary steps to consummate this concurrent detachment and annexation by and between the cities of Independence and Blue Springs.

<u>SECTION 5.</u> That the concurrent and opposite action is being taken by Blue Springs to allow this annexation and detachment of the parcel of property.
