PETITION TO ESTABLISH THE INDEPENDENCE SQUARE COMMUNITY IMPROVEMENT DISTRICT

To the City Council of the City of Independence, Jackson County, Missouri (the "City"):

The undersigned, collectively representing:

- (1) the owners collectively owning more than fifty percent by assessed value of the real property within the boundaries of the hereinafter described community improvement district, and
- (2) more than fifty percent per capita of all owners of real property within the boundaries of the hereinafter described community improvement district,

do hereby petition and request that the City Council of the City of Independence (the "City Council") establish a community improvement district as described herein under the authority of Sections 67.1401 to 67.1571, inclusive, RSMo (the "CID Act").

A. <u>Proposed District Name.</u> The name for the proposed community improvement district (the "**District**") is:

Independence Square Community Improvement District

- **B.** <u>Legal Description and Map</u>. A legal description and map of the District are attached hereto as <u>Exhibit A</u>. The proposed district is located entirely within the corporate boundaries of the City.
- C. <u>Five Year Plan</u>. A five-year plan stating a description of the purposes of the District, the improvements it will make, the services it will perform, and an estimate of the costs to be incurred for the improvements and services is attached hereto as **Exhibit C**.
- **D.** Establishment as Political Subdivision. The District will be established as a political subdivision under the CID Act. The District shall comply with all state statutory requirements of a political subdivision including, but not limited to: (1) State of Missouri open meeting and records law; (2) procurement and public improvement contracting laws, including prevailing wage requirements; and (3) annual comprehensive financial audit.
- **E.** Appointment of Directors. The District will be governed by a Board of Directors, which will consist of seven members. The initial Board of Directors and their initial terms are as follows, with successor Directors elected by the District:
 - 1. Sean Fite- 3 years
 - 2. Amy Knipp- 3 years
 - 3. Kristi Atwood- 3 years
 - 4. Brian Clark- 2 years
 - 5. Michelle DeMoss- 2 years
 - 6. Tom Waters- 2 years
 - 7. Yvonne Hall- 2 years
- **F.** <u>Total Assessed Value</u>. The total assessed value of all real property in the proposed district, as well as information about the assessed value and ownership of each parcel, is set forth in <u>Exhibit B</u>. The

attached **Exhibited B** was prepared based on data available from the Jack County, Missouri, Assessor's Office as of the time of execution of the Petition by the Petitioners. Assed value and parcel number information may have been unavailable or incomplete for certain parcels included in the boundaries of the District. The unavailability of information from the Assessor's Office is outside the control of the Petitioners, and could be based on a number of factors, including, but not limited to, recent transfers of ownership not being updated in the records of the Assessor's Office. The City is authorized by the CID Act to process, consider and approve this petition based on information supplied by the County regarding property values. Total District Assessed Value is \$18,607,934.

- **G.** <u>Blighted Area Determination</u>. The undersigned seek a determination that the District is blighted under the CID Act.
- **H.** <u>Term of Existence</u>. The proposed maximum length of time for the existence of the district is 30 years from the date of the ordinance approving this Petition.
- **I.** <u>Real Property Taxes</u>. There will be no additional property taxes imposed on property within the District.
- J. Special Assessments. There will be no special assessments imposed on property within the District.
- **K.** Proposed CID Sales Tax. The District may, in accordance with the Act and this Petition, impose a CID Sales Tax on all retail sales made in the District which are subject to taxation pursuant to the MISSOURI REVISED STATUTES, Section 144.010 to 144.525, except sales of motor vehicles, trailer, boats or outboard motors and sales to public utilities. Said CID Sales Tax is hereby authorized to be imposed, by submission of the tax by the Board of Directors for vote of the Qualified Voters within the District in accordance with the Act and Petition, in the amount of one percent (1%).
- **L.** <u>Real Estate Tax and Business License Tax</u>. Petitioners will not seek to submit to qualified voters any proposition for approval of a real property tax levy or business license taxes.
- **M.** Borrowing Capacity Limitation. The District's borrowing capacity shall not exceed sixty percent (60%) of its revenue
- N. No Revenue Limitations. Petitioners do not seek limitations on the revenue generation of the District.
- **O.** Other Limitations on the Powers of the District. The District will have the authority and powers granted to community improvement districts and political subdivisions under the Act and as otherwise provided by law.
- P. Severability. If any provision of this Petition shall be held or deemed to be invalid, inoperative or unenforceable as applied in any particular case or in all cases, because in conflict with any other provision or provisions of this Petition or for any other reason, such circumstances shall not have effect of rendering the provision in question inoperative or unenforceable in any other case or circumstance, or of rendering any other provisions contained in this Petition invalid, inoperative or unenforceable to any extent whatsoever.
- **Q.** Request to Establish District. By execution and submission of this Petition, the Petitioners respectfully request that the City Council establish the District as set forth in this Petition.

R. Petitioner Withdrawal Right Notice. THE SIGNATURES OF THE SIGNERS OF THIS PETITION MAY NOT BE WITHDRAWN FROM THIS PETITION LATER THAN SEVEN (7) DAYS AFTER THE FILING HEREOF WITH THE CITY CLERK.

MAP OF THE DISTRICT


