AN ORDINANCE VACATING AN EXISTING 3 FOOT UTILITY EASEMENT, RECORDED IN BOOK 1539 AT PAGE 476, OF THE JACKSON COUNTY DEED RECORDS, AND LOCATED AT 11004 E 40 HIGHWAY.

A 3' utility easement lying on the NW 1/4 of the SE 1/4 of Sec. 21, Twp. 49, Rng. 32, in the City of *Independence, Jackson County, Mo. The centerline of which is described as follows:*

Beginning at a point in the North line of Lot #10, Schowen Heights, 549.5' west of the NE corner of NW 1/4 of SE 1/4 of Sec. 21-49-32, thence South a distance of 152.5 feet, thence Easterly and parallel with the North line of said 1/4 1/4 section a distance of 150 feet.

**Note original easement has a typed 5' width with a hand corrected 3' width.
