**A RESOLUTION REAPPOINTING JOSHUA MAYFIELD AND APPOINTING DANIEL MARTIN TO THE STREET IMPROVEMENT OVERSIGHT COMMITTEE.**

WHEREAS, the City Council of the City of Independence, Missouri, did pursuant to Resolution No. 4530, passed on the 20<sup>th</sup> day of July, 1998, create the Street Improvement Oversight Committee within and for the City of Independence, Missouri; and,

WHEREAS, by the passage of Resolution No. 4538, on September 8, 1998, the City Council named the first seven members of the Street Improvement Oversight Committee; and,

WHEREAS, due to expiration of terms of office, two vacancies have been created; and,

WHEREAS, the City Council deems it advisable to reappoint Joshua Mayfield and appoint Daniel Martin to said Street Improvement Oversight Committee because of their qualities of leadership, temperance, judgment, and interest in promoting public education regarding street projects, and appropriate expenditure of the City's Capital Improvements Sales Tax; and,

WHEREAS, said individuals are duly qualified to so serve, according to the Charter and ordinances of this City and the Council wishes to affirm the individual appointment made by Councilmember Mike Steinmeyer and Councilmember Huff;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:
