RE: Request for PO for Stormwater Repairs

Per the attached proposals from Wiedenmann Construction for the emergency construction of bank stabilization at the 2817 Trenchard and culvert replacement on Truman Road at Yuma, I request approval to issue them a **Purchase Order for \$495,270.00 in addition to continency for future minor change orders for an amount not to exceed \$40,685.00**. Both projects are in critical condition such that failure would result in loss of life and/or property thus, requiring an emergency response.

Design for the repair proposals were prepared by Olsson, an engineering firm, under their design services contract. The proposed repairs have been reviewed and approved by Municipal Services staff.

The vendor providing the construction services, Wiedenman, Inc., provided a quote based on a Lee's Summit Cooperative contract #2019-003/1R. Purchases under cooperative agreements are authorized by Section 8.06.004, Paragraph 5, of the Independence City Code, which states that when cooperative bids or contracts are used, they will first have been established pursuant to generally accepted governmental purchasing practices and the competitive bidding process. The Cooperative contract has been provided for your convenience. See attachments #1 and #2 for detail breakdown of costs.

Although not shown in the total costs, Wiedenmann Inc. did note that by using Municipal Services dump trucks and drivers as specified therein, we could realize a savings up to \$46,000.




Figure 1 – Bank Stabilization Locations

Additional sites, as shown in Figure 1, require emergency bank stabilizations. However, they are not included with this request as the design consultant continues to develop plans for these sites. Once design is completed and approve, a separate PO or change order will be prepared to address these items at a later date.
