AN ORDINANCE APPROVING THE AMENDED 2019-2020 ANNUAL ACTION PLAN FOR PROGRAM YEAR 45 AND AN AMENDMENT TO THE 2017-21 CONSOLIDATED PLAN AND MAKING THE NECESSARY APPROPRIATIONS.

WHEREAS, on June 1, 2020, the City Council approved Annual Action Plan for Program Year 45 to incorporate the use of CDBG-CV funds; and,

WHEREAS, the required 2017-2021 Consolidated Five Year Plan and the 2019-2020 Annual Action Plan are being amended for a Rental Assistance program targeting individuals and families recovering from financial hardship caused by directly or indirectly from COVID-19;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Manager is hereby authorized and directed to submit the amended Annual Action Plan to the Department of Housing and Urban Development (HUD) for Program Year 45 of the Community Development Program (CDBG), and submit the amended 2017-2021 Consolidated Plan, and recommending the following changes to projects and programs for the 2019-2020 Program Year:

SECTION 2. That upon HUD's acceptance of the City's amended Annual Action Plan, the City Manager is authorized to exercise any and all necessary powers available to him to implement those projects listed in the amended Annual Action Plan, including execution of HUD funding agreements and sub-grant Agreements for the administration of said projects.

SECTION 3. That upon the final execution of funding agreements between the City and HUD, appropriations are hereby authorized to be increased for the purposes and from the sources listed on this ordinance.
