WHEREAS, the District did prepare and submit such proposed budget for the 2020-21 Fiscal Year to the City (the "Proposed Budget");

WHEREAS, the City had no comments to the Proposed Budget; and

WHEREAS, the District desires to ratify, acknowledge and accept the Proposed Budget submitted to the City and the actions taken therein;

WHEREAS, the District desires to approve the Proposed Budget as the District's Budget for Fiscal Year 2020-21.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the District as follows:

- 1. That the actions taken on behalf of the District in preparing and submitting the Proposed Budget to the City, are hereby ratified, acknowledged and accepted.
- 2. That the Proposed Budget for the Fiscal Year beginning July 1, 2020 and ending June 30, 2021, attached hereto as Exhibit A, is hereby accepted and approved as the District's Fiscal Year 2020-21 Budget.
  - 3. This resolution shall take effect immediately.
