**2020 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD
Grant Cycle October 1, 2019-September 30, 2023**

This Agreement is made and entered into this ___ day of August 2020, by and between the CITY of Kansas City, Missouri and the county of Jackson (COUNTY), and the CITY of Independence (CITY1), and the CITY of Grandview (CITY2) and the CITY of Raytown (CITY3).

WHEREAS, the U.S. Department of Justice, Office of Justice Programs has collectively allotted \$588,501 to the above-named units of government for state and local law enforcement related initiatives; and

WHEREAS, each governing body agrees that the CITY of Kansas City Missouri shall serve as the fiscal agent for the funds; and

WHEREAS, each governing body finds that the performance of this AGREEMENT is in the best interest of all parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services of functions under this agreement; and

WHEREAS, the CITY of Kansas City, Missouri agrees to provide the COUNTY of Jackson \$253,055.43 from the JAG award to pay salaries and benefits of staff in the Jackson County Prosecutor's Office.

WHEREAS, the CITY agrees to provide CITY1 \$50,022.59 for the JAG award to purchase law enforcement equipment and new technology for the Crime Scene Unit; and

WHEREAS, the CITY agrees to provide the CITY2 \$10,415.00 for the JAG award to purchase Law Enforcement related equipment for public safety; and

WHEREAS, the CITY agrees to provide the CITY3 \$10,829.00 for the JAG award to purchase Law Enforcement related equipment for public safety; and

WHEREAS, the CITY agrees to \$264,178.98 from the JAG award for Neighborhoods and Housing Services, Kansas City Police Department, and Kansas City Metropolitan Crime Commission; and,

WHEREAS, the CITY, COUNTY, CITY1, CITY2 and CITY3 believes it to be in their best interests to reallocate JAG funds.

Section 1.

CITY of Kansas City, Missouri agrees to pay the COUNTY of JACKSON \$253,055.43 of JAG funds.

COUNTY of Jackson agrees to use the \$253,055.43 for salaries and benefits of staff in the Jackson County Prosecutor's Office.

Section 2.

CITY of Kansas City, Missouri agrees to pay CITY1 a total of \$50,022.59 of JAG funds.

CITY1 agrees to use \$50,022.59 to purchase law enforcement equipment and new technology for the Crime Scene Unit.

Section 3.

CITY of Kansas City, Missouri agrees to pay CITY2 a total of \$10,415.00 of JAG funds.

CITY2 agrees to use \$10,415.00 to purchase Law Enforcement Equipment.

Section 4.

CITY of Kansas City, Missouri agrees to pay CITY3 a total of \$10,829.00 of JAG funds.

CITY3 agrees to use \$10,829.00 to purchase Law Enforcement Equipment.

CITY of Kansas City, Missouri agrees to receive a total of \$264,178.98 of JAG funds.

COUNTY of JACKSON agrees to use the \$264,178.98 for Neighborhoods and Housing Services, Kansas City Police Department, and Kansas City Crime Commission

Section 5.

Nothing in the performance of this Agreement shall impose any liability for claims against all participating CITIES under this Memorandum of Understanding.

Section 5.

Nothing in the performance of this Agreement shall impose any liability for claims against the COUNTY.

Section 6.

Each party to this agreement shall be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by one or more of the other parties.

Section 7.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this agreement.

Section 8.

By entering into this Agreement, the parties do not intend to create any obligations express or implies other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.


