A RESOLUION AUTHORIZING THE ACCEPTANCE OF FUNDING FROM THE U.S. DEPARTMENT OF JUSTICE, BUREAU OF JUSTICE ASSISTANCE, OFFICE OF JUSTICE PROGRAMS, FY 2020 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM, THROUGH A KANSAS CITY, MISSOURI ORDINANCE NO. 210071, WHICH ALLOCATES \$50,022 TO THE CITY OF INDEPENDENCE, MISSOURI, FOR THE POLICE DEPARTMENT'S USE.

WHEREAS, the City Council of the City of Independence, Missouri, finds it in the best interest of the City to participate as fully as possible in programs with other law enforcement agencies and other funding agencies to create and maintain an atmosphere as safe as possible for the citizens of Independence; and,

WHEREAS, the City of Kansas City, Missouri, has received funds through the 2020 Byrne Justice Assistance Grant (JAG) Program Award from the U.S. Department of Justice for state and local law enforcement related initiatives; and,

WHEREAS, the City of Kansas City, Missouri, has made available a total of Fifty Thousand Twenty Two and NO/100 Dollars (\$50,022.00) and has authorized the allocation of said funds through their City Council Ordinance No. 210071 for the City of Independence, Missouri Police Department;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Council hereby directs the City Manager of the City of Independence, Missouri, to accept the 2020 Byrne JAG Program Award funds from the City of Kansas City, Missouri in the amount of Fifty Thousand Twenty Two and NO/100 Dollars (\$50,022.00) for the Police Department to purchase law enforcement equipment to include ballistic shields for the SWAT unit, as well as new technology for the Crime Scene Unit, a copy of the JAG Proposal and subsequent Kansas City, Missouri Ordinance being attached hereto, incorporated by reference thereto, and made a part of hereof as though fully set out herein.

SECTION 2. That the City Manager is further authorized to approve future change orders, extensions, amendments or addendums to this grant without Council approval, for an extension of time for completing the terms of the grant or for the receipt of additional funding for this same grant project, provided there are no changes in the terms and/or conditions or responsibilities to the City and provided each and every such change order, extension, amendment or addendum is approved by the City Manager, does not add more than 90% to the length of time of the grant or more than 50% to the original funding, is identified as being authorized by this ordinance and a copy is filed with the City Clerk.

SECTION 3. That appropriations in the Police Department Grant Fund Operating Budget in the amount of Fifty Thousand Twenty-Two and NO/100 Dollars (\$50,022.00)) from increased estimated revenues from the anticipated grant funding for this Justice Assistance Grant Program Award will be incorporated within the next quarterly appropriation ordinance.
