Inclusions:

- Point repair of 20" DIP water main.
 - Clearing and grubbing on north and south side of the creek for access to repair from both sides.
 - Bypass pumping of the creek from the west side of Powell Rd, through the box culvert, and 75' to the east to gain access to the pipe.
 - o Cutting out and replacing leak with 20" DIP Pipe, 2 sleeves and megalugs.
 - o Pipe embedment.
 - Concrete encasement around the pipe for the width of the creek channel.
 - 60' x 10' x 2' Rip Rap with grout to extend the box culvert in an attempt to stop the erosion from around the pipe.
 - Straddle block on the north and south side of the creek to hold the pipe crossing due to unknown joints.

Exclusions:

- Pipe and fittings are to be supplied by the city and are not included.
- Survey, layout and material/density testing, traffic control and as-built surveys are not included.
- All seeding, sodding, restoration, street, asphalt, curb, sidewalk, handicap ramps, fence, irrigation/sprinkler system and lawn restoration on or off site are not included unless specifically stated otherwise in the inclusions.
- Creek Bank Stabilization is not included.
- Performance & payment and maintenance bonds are not included.
