AN ORDINANCE APPROVING A REZONING FROM DISTRICT R-30/PUD (HIGH DENSITY RESIDENTIAL/PLANNED UNIT DEVELOPMENT) TO DISTRICT R-6 (SINGLE FAMILY RESIDENTIAL) FOR PART OF THE PROPERTY AT 218 N. DELAWARE AVENUE IN INDEPENDENCE, MISSOURI.

WHEREAS, the application submitted by Rebecca Cornish, requesting approval of a rezoning from District R-30/PUD (High Density Residential/Planned Unit Development) to District R-6 (Single Family Residential) for part of the property at 218 N. Delaware Avenue was referred to the Planning Commission as required by the Unified Development Ordinance; and,

WHEREAS, the Unified Development Ordinance provides for the approval of a rezoning following public hearings by the Planning Commission and City Council; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a virtual public hearing for the consideration of the request on June 22, 2021, and rendered a report to the City Council recommending that the rezoning be approved by a vote of 6-0; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on July 19, 2021, and rendered a decision to approve the rezoning of the said property; and,

WHEREAS, in accordance with the Unified Development Ordinance, it was determined that the rezoning was consistent with the review criteria in Section 14-701-02; and,

WHEREAS, no legal protests were signed, acknowledged, and presented for the application.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

<u>SECTION 1.</u> That the following legally described property is hereby rezoned from District R-30/PUD (High Density Residential/Planned Unit Development) to District R-6 (Single Family Residential) and shall be subject to the regulations of said district:

Part of Lot 5, James F. Moore's Addition, a subdivision in Independence, Jackson County, Missouri described as follows: Beginning on the Southwest corner of said lot thence Easterly 63.36 feet; thence Northerly 50 feet to the Point of Beginning: Thence Northerly 10 feet; thence Easterly 18 feet; thence Southerly 10 feet; thence Westerly 18 feet to the Point of Beginning.

SECTION 2. Nonseverability. All provisions of this ordinance are so essentially, and inseparable connected with, and so dependent upon, each other that no such provision would be enacted without all others. If a court of competent jurisdiction enters a final judgement on the merits that is not subject to appeal and that declares any provision or part of this ordinance void, unconstitutional, or unenforceable, then this ordinance, in its collective entirety, is invalid and shall have no legal effect as of the date of such judgement.

<u>SECTION 3.</u> Scrivener's Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this ordinance, as determined by the City Clerk and City Counselor, may be corrected with the endorsement of the City Manager without the need to come before City Council.
