AN ORDINANCE AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT FROM MID-AMERICA REGIONAL COUNCIL IN THE AMOUNT OF \$203,443 FOR THE CITY'S SENIOR ADULT NUTRITION SITE PROGRAM FOR FISCAL YEAR 2021-2022 AND EXECUTE THE AMENDMENT TO THE COMMUNITY CENTER SERVICES AGREEMENT; MAKING THE NECESSARY APPROPRIATIONS; AUTHORIZING FUTURE CHANGE ORDERS FOR ADDITIONAL FUNDING AND/OR TIME EXTENSIONS; AND, AUTHORIZING CERTAIN FUTURE APPROPRIATIONS.

WHEREAS, the Mid-America Regional Council (MARC) has been conducting a Senior Adult Nutrition site in Independence at the Palmer Center at 218 N. Pleasant under authority of Ordinance No. 18160; and,

WHEREAS, the City of Independence has deemed it appropriate to continue to provide a nutrition center at Palmer Center; and,

WHEREAS, for Fiscal Year 2021-22 the Mid-America Regional Council awarded the City of Independence Thirty Thousand and NO/100 Dollars (\$30,000.00) in grant funding for administering the Senior Adult Nutrition Site program; and,

WHEREAS, for Fiscal Year 2021-22, the Mid-America Regional Council awarded the City of Independence additional reimbursements up to Eighteen Thousand Seven Hundred Fifty and NO/100 Dollars (\$18,750.00) for participant transportation services to and from the Palmer Center's Senior Adult Nutrition Site; and,

WHEREAS, for Fiscal Year 2021-22, the Mid-America Regional Council awarded the City of Independence additional reimbursements up to Ten Thousand and NO/100 Dollars (\$10,000.00) for performing In-Home Assessments and Assessments/Reassessments required for the Home Delivered Meal program recipients; and,

WHEREAS, for Fiscal Year 2021-22, the Mid-America Regional Council awarded the City of Independence additional reimbursements up to Twenty Thousand and NO/100 Dollars (\$20,000.00) for Evidence-Based Disease Prevention/Health Promotion Programs; and,

WHEREAS, for Fiscal Year 2021-22, the Mid-America Regional Council awarded the City of Independence additional reimbursement up to One Hundred Twenty Four Thousand Six Hundred Ninety-Three and No/100 Dollars (\$124,693.00) for new projects under the special congregate and home delivered meals funding; and

WHEREAS, the adopted budget for Fiscal Year 2021-22 originally included an appropriation of Thirty Thousand and NO/100 Dollars (\$30,000.00) in the Parks, Recreation, Tourism Department Operating Budget within the Senior Adult Services Division for anticipated annual grant funding from Mid-America Regional Council;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Manager of the City of Independence, Missouri, is hereby authorized and directed to execute, for and on behalf of said City, an Amendment to the Community Center Services Agreement (Contract #19-2961014-CI) with the Mid-America Regional Council for the provision of a nutrition site at the Palmer Center under the guidelines of the MARC Commission on Aging Policies and Procedures Manual, from July 1, 2021 through June 30, 2022, for a subsidy of Thirty Thousand and NO/100 Dollars (\$30,000.00), plus additional reimbursements up to a maximum of Eighteen Thousand Seven Hundred Fifty and NO/100 Dollars (\$18,750.00) for participant transportation services, Ten Thousand and NO/100 Dollars (\$10,000.00) for In-Home Assessments and Assessments/Reassessments for Home Delivered Meals, Twenty Thousand and NO/100 Dollars (\$20,000.00) for Evidence-Based Disease Prevention/Health Promotion Programs, and One Hundred Twenty Four Thousand Six Hundred Ninety-Three and No/100 Dollars (\$124,693.00) for new projects under the special congregate and home delivered meals funding, a copy of the amended agreement being attached hereto, incorporated herein by reference thereto, and made a part hereof as though fully set out herein.

SECTION 2. That appropriations are hereby increased in the Parks, Recreation and Tourism Department Operating Budget within the Parks & Recreation Grant Fund in the amount of One Hundred Seventy Three Thousand Four Hundred Forty-Three and No/100 Dollars (\$173,443.00) for participant transportation to and from the Nutrition Site (\$18,750.00), salaries for personnel to complete In-Home Assessments and Assessments & Reassessments for Home Delivered Meals (\$10,000.00), costs associated with offering Evidence-Based Disease Prevention/Health Promotion Programs (\$20,000.00), and new projects under the special congregate and home delivered meals funding (\$124,693.00), from grant reimbursement revenues received from the Mid-America Regional Council.

SECTION 3. That the City Manager is further authorized to approve future change orders, extensions, amendments or addendums to this agreement without Council approval, or an extension of time for completing the terms of the grant or for the receipt of additional funding for this same grant project, provided there are no changes in the terms and/or conditions or responsibilities to the City and provided each and every such change order, extension, amendment or addendum is approved by the City Manager, does not add more than 90% to the length of time of the grant or more than 50% to the original funding, is identified as being authorized by this ordinance and a copy is filed with the City Clerk.

SECTION 4. That the City Manager is hereby authorized to increase appropriations by the amount of any increased grant awards authorized by change order, extension, amendment or addendum for any increased funding under the terms of the previous section, provided a copy of that action is also provided to the Finance Department.
