ORDINANCE NO. _____

AN ORDINANCE APPROVING A REZONING FROM DISTRICT C-2 (GENERAL COMMERCIAL) TO DISTRICT R-12 (TWO FAMILY RESIDENTIAL) FOR NUMEROUS PROPERTIES ON SOUTH OXFORD AVENUE IN INDEPENDENCE, MISSOURI.

WHEREAS, the application submitted by City of Independence, requesting approval of a rezoning from District C-2 (General Commercial) to District R-12 (Two Family Residential) for the properties at 3324/3326, 3328/3330, 3332/3334, 3404/3406, 3408/3410, 3412/3414, 3416/3418, 3420/3422, 3424/3426, 3428/3430, 3436/3438 S. Oxford Avenue was referred to the Planning Commission as required by the Unified Development Ordinance; and,

WHEREAS, the Unified Development Ordinance provides for the approval of a rezoning following public hearings by the Planning Commission and City Council; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a virtual public hearing for the consideration of the request on July 27, 2021, and rendered a report to the City Council recommending that the rezoning be approved by a vote of 6-0; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on September 7, 2021, and rendered a decision to approve the rezoning of the said properties; and,

WHEREAS, in accordance with the Unified Development Ordinance, it was determined that the rezoning was consistent with the review criteria in Section 14-701-02; and,

WHEREAS, no legal protests were signed, acknowledged, and presented for the application.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the following legally described property is hereby rezoned from District C-2 (General Commercial) to District R-12 (Two Family Residential) and shall be subject to the regulations of said district:

The South 12 feet of Lot 6, and the North 50 feet of Lot 7, of the Corrected Plat of Kleuver Homestead;

the South 10 feet of Lot 7 and the North 52 feet of Lot 8, Kleuver Homestead;

the South 8 feet of Lot 8 and the North 54 feet of Lot 9, Kleuver Homestead;

the South 6 feet of Lot 9 and the North 56 feet of Lot 10, Kleuver Homestead;

the South 4 feet of Lot 10 and the North 58 feet of Lot 11, Kleuver Homestead;

the South 2 feet of Lot 11 and all of Lot 12, Kleuver Homestead;

and all of Lots 13, 14, 15, and 16, Kleuver Homestead;

these subdivisions being in Independence, Jackson County, Missouri

SECTION 2. Nonseverability. All provisions of this ordinance are so essentially, and inseparable connected with, and so dependent upon, each other that no such provision would be enacted without all others. If a court of competent jurisdiction enters a final judgement on the merits that is not subject to appeal and that declares any provision or part of this ordinance void, unconstitutional, or unenforceable, then this ordinance, in its collective entirety, is invalid and shall have no legal effect as of the date of such judgement.

SECTION 3. Scrivener’s Errors. Typographical errors and other matters of a similar nature that do not affect the intent of this ordinance, as determined by the City Clerk and City Counselor, may be corrected with the endorsement of the City Manager without the need to come before City Council.

SECTION 4. That failure to comply with all the provisions contained in this ordinance shall constitute violations of both this ordinance and Chapter 14, the Unified Development Ordinance, of the Code of the City of Independence, Missouri.
