SUBJECT: Boards and Commission Recording Requirements

Staff is seeking clarification and direction from the Council regarding when and how boards and commissions meetings are handled as it relates to recordings and livestreaming.

The following boards and commissions have recording requirements, which were approved by Res. No. 6224 and Res. No. 6711:

- Board of Adjustment
- Board of Ethics
- Planning Commission
- City Judicial Commission
- Personnel Board
- PUAB
- TIF Commission
- Audit and Finance

Additional Information:

- To provide quality recordings, the following needs to occur:
 - The board or commission would need to meet 100% online
 - The board or commission would need to meet in the Council Chambers or the Independence Utilities Center Conference Room
 - Any in person or virtual meetings requiring a livestream component cannot occur simultaneously.
- Staff time:
 - O Virtual meetings take staff approximately 25 minutes to setup, make quality adjustments and upload the videos to the City's YouTube Page.



- This time does not include the duration of the meeting staff is monitoring for quality and technology.
- o In-person meetings take staff approximately 60 minutes to setup, take down and make any quality adjustments. This time does not include the duration of the meeting staff is monitoring for quality and technology.
 - For each Council meeting, there is approximately 7 hours of staff time for set-up, producing and posting the meeting.
- While the Communications Team currently has two FTEs able to cover public meetings, equipment needed to accommodate recording, livestreaming and web-site upload requests does not allow for more than one meeting at a time.
 - If additional meetings are added we will have to start eliminating production of PSAs, event spotlights, heritage month features, etc., or additional resources will be required.
 - For each 3–5-minute video there is a minimum of 3-5 hours of videography and editing required.
- o In FY 20-21, 222 Live Meetings were aired and created 32 other videos for the public.
 - So far in FY 21-22, we have aired 17 public meetings and 6 informational/promotional videos.

Staff Recommendations:

• Staff is recommending amending Res. No. 6224 and repealing Res. No. 6711 to add all required boards and commissions including Audit and Finance in one resolution. Staff would add any direction from Council in said resolution to define and clarify the process and expectations for meetings.
