AN ORDINANCE AUTHORIZING A CONTRACT WITH LINAWEAVER CONSTRUCTION, INC. FOR THE INSTALLATION OF AN 8-INCH DIAMETER DUCTILE IRON WATER MAIN FOR THE GUDGELL AVENUE (DODGION – KINGS HIGHWAY) WATER MAIN REPLACEMENT CAPITAL IMPROVEMENT PROJECT FOR AN AMOUNT NOT TO EXCEED \$1,165,500.00; AUTHORIZING MINOR CHANGE ORDERS FOR AN AMOUNT NOT TO EXCEED \$116,550.00 AND/OR TIME EXTENSIONS; AND INCREASING APPROPRIATIONS.

WHEREAS, Linaweaver Construction Inc. is a Kansas City Metro area construction company; and,

WHEREAS, Linaweaver Construction Inc. is offering construction services to the City to install a 8-inch water main on Gudgell Avenue; and,

WHEREAS, the Water Department recommends the execution of a contract to Linaweaver Construction Inc.:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

<u>SECTION 1</u>. That the City Manager of the City of Independence, Missouri, shall be and is hereby authorized and directed to sign and execute for and on behalf of said City a contract with Linaweaver Construction Inc. providing for the installation of an 8-inch ductile iron water main on Gudgell Avenue for a sum not to exceed One Million One Hundred Sixty-Five Thousand Five Hundred Dollars (\$1,165,500.00).

<u>SECTION 2</u>. That the City Manager is authorized to appropriate Two Hundred Seventy-Three Thousand Six Hundred Eighty-Five Dollars (\$273,685.00) from the Water Department Unreserved Retained Earnings to cover a sum of the following: the difference in the contract cost of \$130,500.00 (Contract amount of \$1,165,500.00 – budgeted amount of \$1,035,000.00), 10% change order allowance of \$116,550.00, and the consultant engineering fee (surveying and design) of \$26,635.00.

SECTION 3. That the City Manager is further authorized to approve future change orders to the contract as may be necessary to complete the project without Council approval, as long as the total of all such change orders does not exceed One Hundred Sixteen Thousand Five Hundred Fifty Dollars (\$116,550.00) and/or time extensions as deemed appropriate by the City Manager, the funds necessary for said change orders are in fact available and provided a copy of each change order is approved by the City Manager, is identified as being authorized by this ordinance and is filed with the City Clerk.
