AN ORDINANCE ADOPTING AMENDMENTS TO THE FISCAL YEAR 2021- 2022 BUDGET, WHICH WAS APPROVED BY ORDINANCE NO. 19228.
WHEREAS, the adopted Operating and Capital budgets for the 2021-22 fiscal year were approved by the City Council by Ordinance No. 19228; and,
WHEREAS, since that time some circumstances have arisen that necessitate changes to the appropriations established in the adopted budget; and,
WHEREAS, these changes are listed in detail in terms of background, purpose and funding source in the attached agenda item cover sheet;
NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:
SECTION 1. Increasing appropriations in the amount of \$53,654.00 in the Water Fund (No. 040) from Unassigned Fund Balance for payment of cashier services at City Hall.
SECTION 2. Transferring appropriations between Municipal Court and Finance & Administration in the amount of \$39,000.00 within the General Fund (No. 002) for Youth Court grant funds.
SECTION 3. Increasing appropriations in the amount of \$303,300.00 in the Water Fund (No. 040) from Unassigned Fund Balance for repairs to the Van Horn Reservoir.
SECTION 4. Increasing revenues in the amount of \$5,000.00 from grants for Police programs and services in the Grants Fund (No. 015) and appropriating a total of \$5,000.00 to the Police Grants account in the Grant Fund (No. 015).
SECTION 5. Decreasing revenues in the amount of \$58,850.00 for various Health Department permits in the General Fund (No. 002) and increasing revenues in the amount of \$58,850.00 for various Health Department permits in the Health Property Tax Levy (No. 005).
SECTION 6. Increasing revenues in the amount of \$100,000.00 from internal service charges and appropriating a total of \$100,000.00 for the City's lease program with Enterprise Fleet Management within the Central Garage Fund (No. 090).
SECTION 7. Increasing revenues in the amount of \$30,000.00 in the Tourism Fun (No. 004) as a result of the National Frontier Trails Museum opening.
SECTION 8. Increasing appropriations in the amount of \$50,500.00 in the General Fund (No. 002) from Unassigned Fund Balance for projected expenses for the Special Election to be held on November 2, 2021.
