Please accept this application for a short-term rental permit at the above address.

- 1. Bedrooms: 1 initially; 2 may be rented in the future
- 2. Total occupancy: 2 initially; may expand to 4 in the future
- 3. Square footage of building: 877
- 4. Available parking spaces: 3
- 5. Refuse collection plan: Ted's Trash; weekly pickup
- 6. We will comply with safety requirements per city code
- 7. Marketing website: Airbnb
- 8. Addressing loud or unruly guests or complaints from neighbors related to disturbances: Airbnb guests are given reviews and ratings by owners. Prospective guests are vetted through this system. An owner has the right to deny a request for a stay for any reason. Owners may report information to be added to the guest's profile. Airbnb blocks reservation requests and inquiries from prospective guests who have received negative ratings. Owners may also post house rules prohibiting loud parties.
- 9. Number of vehicles may be limited per house rules on reservation website.
- 10. Airbnb requires that the number of guests be stated on the reservation request.
