AN ORDINANCE TERMINATING TAX INCREMENT FINANCING WITHIN THE MOUNT WASHINGTON REDEVELOPMENT AREA; DISSOLVING THE SPECIAL ALLOCATION FUND ACCOUNTS RELATED THERETO; AND AUTHORIZING CERTAIN ACTIONS RELATING THERETO.

WHEREAS, the Real Property Tax Increment Allocation Redevelopment Act, Sections 99.800 to 99.865 of the Revised Statutes of Missouri, as amended (the "Act"), authorizes municipalities to undertake redevelopment projects in blighted or conservation areas, as defined in the Act; and,

WHEREAS, on September 18, 2000, the City Council adopted Ordinance No. 14608 approving the Mount Washington Tax Increment Financing Plan (the "Redevelopment Plan"), designating the redevelopment area described in the Redevelopment Plan (the "Redevelopment Area") as a "redevelopment area" under the Act, approving a redevelopment project (the "Redevelopment Project") and adopting tax increment financing within the Redevelopment Area; and,

WHEREAS, the City Council hereby finds that portions of Redevelopment Project have been completed, for which all certified reimbursable project costs have been reimbursed, and the remaining portions of the Redevelopment Project will not be undertaken, and, therefore, it is in the best interest of the City and the other affected taxing districts to terminate tax increment financing within the Redevelopment Area.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby declares as surplus all economic activity taxes (as defined in the Act) on deposit in the account of the Special Allocation Fund created by Ordinance No. 14608 (the "Special Allocation Fund"). Such surplus economic activity taxes shall be paid to the taxing districts from which they originate, as provided in Section 99.820 of the Act.

SECTION 2. The City Council hereby terminates tax increment financing within the Redevelopment Area.

SECTION 3. The City Clerk or other appropriate official is hereby directed to dissolve the Special Allocation Fund. All administrative expenses, including legal fees, related to the dissolution of the Special Allocation Fund and the termination of tax increment financing within the Redevelopment Area shall be paid from the moneys in the Special Allocation Fund. All remaining moneys in the Special Allocation Fund, after the payment of the administrative expenses and the distribution of surplus economic activity taxes as described above, shall be paid to the County Collector or other appropriate office for distribution to the appropriate taxing districts in the manner provided in the Act.

<u>SECTION 4</u>. The officers, agents and employees of the City are hereby authorized and directed to execute all documents and take such necessary steps as they deem necessary and advisable to carry out and perform the purpose of this Ordinance.

<u>SECTION 5</u>. The sections of this Ordinance shall be severable. If any section of this Ordinance is found by a court of competent jurisdiction to be invalid, the remaining sections shall remain valid, unless the court finds that the valid sections are so essential to and inseparably connected with and dependent upon the void section that it cannot be presumed that the City Council has or would have enacted the valid sections without the void ones, unless the court finds that the valid sections, standing alone, are incomplete and are incapable of being executed in accordance with the legislative intent.

<u>SECTION 6</u>. This Ordinance shall take effect and be in full force on the 11th day after its passage by the City Council.
