AN ORDINANCE AUTHORIZING ISSUANCE OF A PURCHASE ORDER TO GENESIS ENVIRONMENTAL SOLUTIONS, INC. FOR CONTACT BASIN NO. 3 PROTECTIVE COATING SYSTEMS REPLACEMENT AT THE COURTNEY BEND WATER TREATMENT PLANT FOR \$442,270.00; AUTHORIZING FUTURE CHANGE ORDERS NOT TO EXCEED \$44,227.00, AND/OR TIME EXTENSIONS AS DEEMED APPROPRIATE; AND APPROPRIATING \$76,497.00 FROM THE WATER FUND NET ASSETS.

WHEREAS, the City Council of the City of Independence, Missouri, finds it necessary to replace the protective coating systems of contact basin no. 3 structures at the Courtney Bend Water Treatment Plant; and,

WHEREAS, the Director of the Water Department, pursuant to the Charter and ordinances of the City of Independence, Missouri, did advertise for bids; and,

WHEREAS, the bid of Genesis Environmental Solutions, Inc, a Kansas City Metro area Heavy Industrial Equipment Maintenance Service provider headquartered in Jackson County, MO, for replacement of the protective coatings systems of contact basin no. 3 structures at the Courtney Bend Water Treatment Plant for a sum of Four-Hundred Forty-Two Thousand Two Hundred Seventy Dollars and Zero Cents (\$442,270.00) was, by City Staff and City Council, deemed the lowest and best bid for the performance of this work, and it is now the City Council's desire to award said project and to authorize additional funding of Forty-Four Thousand Two Hundred Twenty-Seven Dollars and Zero Cents (\$44,227.00) for minor changes orders and to provide an allowance for time extensions if deemed necessary; and to appropriate Seventy-Six Thousand Four Hundred Ninety-Seven Dollars and Zero Cents (\$76,497.00) from the Water Fund's Net Assets to cover the costs of this project;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Manager of the City of Independence, Missouri, shall be and is hereby authorized and directed to issue a purchase order to Genesis Environmental Solutions, Inc. providing for protective coating systems replacement of contact basin no. 3 structure at the Courtney Bend Water Treatment Plant for a sum not to exceed Four-Hundred Forty-Two Thousand Two Hundred Seventy Dollars and Zero Cents (\$442,270.00), pursuant to the terms, conditions, and provisions of said project, incorporated by reference hereto, and made a part of hereof as though fully set out herein.

SECTION 2. That the City Manager is authorized to appropriate Seventy-Six Thousand Four Hundred Ninety-Seven Dollars and Zero Cents (\$76,497.00) from the Water Fund net assets to the Water Department FY21-22 operating account.

SECTION 3. That the City Manager is further authorized to approve future change orders to the purchase order as may be necessary to complete the project without Council approval, as long as the total of all such change orders does not exceed Forty-Four Thousand Two Hundred Twenty-Seven Dollars and Zero Cents (\$44,227.00) and/or time extensions as deemed appropriate by the City Manager, the funds

necessary for said change orders are in fact available and provided a copy of each change order is approved by the City Manager, is identified as being authorized by this ordinance and is filed with the City Clerk.
