An ordinance approving the amended 2021-22 annual action plan and making the necessary appropriations.

WHEREAS, on July 6, 2021, the City Council approved the 2021-22 Annual Action Plan for the CDBG Program Year 47 and HOME Program Year 27 for activities and programs that benefit the low- to moderate-income citizens of Independence; and

WHEREAS, the City is a Participating Jurisdiction (PJ) in the HOME Investment Partnership program (HOME); and,

WHEREAS, the City received \$18,034.80 of HOME program income from prior year HOME activities; and,

WHEREAS, the Department of Housing and Urban Development (HUD) requires PJs to commit HOME program income to the HOME program prior to the subsequent year's grant allocation; and,

WHEREAS, HOME program income in the amount of \$18,034.80 has been allocated in the Amended 2021-2022 Annual Action Plan for HOME Program Year 27.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Manager is hereby authorized to submit the City's Amended 2021-2022 Annual Action Plan with the following projects and amended funding amounts to HUD.:
