REGULAR MEETING February 28, 2022

The Independence City Council met for a Special Called Meeting, February 28, 2022, at 7:28 p.m., virtually held via Microsoft Teams and in person, in the Council Chambers, 111 E. Maple.

Mayor Eileen Weir, Presiding Officer of the City Council, called the meeting to order. Upon roll call, the following members of the City Council were present: Mike Huff, John Perkins, Brice Stewart, Karen DeLuccie, Mike Steinmeyer, Daniel Hobart and Mayor Eileen Weir. The following members of the City Council were absent: None. Councilmember Karen DeLuccie attended virtually.

CITIZENS REQUEST TO SPEAK:

Kevin Baird spoke to Council regarding IPL's proposed new generation plan.

Bridgett McCandless spoke to Council regarding the IPL generator item.

Lowell Krofft spoke to Council regarding the IPL new generation plan.

NON-ORDINANCE ACTION ITEMS:

1. Council action is recommended to authorize the City Manager to execute a Letter of Intent with PROENERGY Services, LLC and/or its assignees for the Independence Power & Light Substation A Generation Project, RFP 21094.

Councilmember DeLuccie stated she is in favor of this project. Councilmember Steinmeyer stated there are other questions that should be considered, such as the debt and what we are getting in return. Councilmember Steinmeyer stated that he feels because this is a public utility that we need more input from the public. Councilmember Steinmeyer stated it may be beneficial to hold a public hearing before voting on this item. Mayor Weir stated that public input is critical, and she has strongly encouraged PUAB to hold public hearings and to this point they have not, but that opportunity is still an option. Mayor Weir stated that Council would like to hear directly from the experts that have been consulted on this item. Mayor Weir stated that it will take the community coming forward to help organize a Town Hall event to allow the public to ask the questions to the appropriate people. Mayor Weir stated that she believes we should still use internal staff and not go the IPL strategic planning route. Mayor Weir stated that a public vote of this magnitude may be warranted. Mayor Weir stated that if Council does not direct staff to move forward, we will not get a chance to ask the needed questions and stated that this is a necessary step to bring forward the experts for this community to make this very important decision. Mayor Weir stated that she will be supporting this item.

Upon roll call, the vote was: Ayes – Councilmembers: Perkins, DeLuccie, Hobart and Mayor Weir. Noes – Councilmembers: Huff, Stewart and Steinmeyer. Absent – None. The Mayor declared the item approved.
