AN ORDINANCE AUTHORIZING THE ACCEPTANCE OF A CONTRACT WITH JACKSON COUNTY, MISSOURI, WHICH CALLS FOR JACKSON COUNTY TO PROVIDE FUNDING IN THE AMOUNT OF \$225,000.00 TO THE CITY FOR INDEPENDENCE POLICE DEPARTMENT'S LAW ENFORCEMENT SCHOOL BASED INITIATIVE CALLED S.T.E.P.

WHEREAS, Jackson County has offered to provide funding to the City of Independence out of the County's Anti-Drug Sales Tax Funds and by County Resolution No. 20857 did authorize funding in the amount of Two Hundred Twenty-Five Thousand and NO/100 Dollars (\$225,000.00) to assist in defraying the costs of the Independence Police Department's S.T.E.P. program; and,

WHEREAS, the City Council does wish to accept the Agreement for the purpose stated.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Council hereby directs the City Manager to sign a Cooperative Agreement, and related documents, from Jackson County, Missouri in the amount of Two Hundred Twenty-Five Thousand and NO/100 Dollars (\$225,000.00) to partially fund the Independence Police Department's S.T.E.P. (Students Transitioning Exceptionally Prepared) program, a copy of which is attached hereto, incorporated by reference thereto, and made a part hereof as though fully set out herein.

SECTION 2. That the City Manager is further authorized to approve future change orders, extensions, amendments or addendums to this agreement without Council approval, or an extension of time for completing the terms of the agreement or for the receipt of additional funding for this same project, provided there are no changes in the terms and/or conditions or responsibilities to the City and provided each and every such change order, extension, amendment or addendum is approved by the City Manager, does not add more than 90% to the length of time of the program or more than 50% to the original funding, is identified as being authorized by this ordinance and a copy is filed with the City Clerk.

SECTION 3. That the City Manager is hereby authorized to increase appropriations by the amount of any increased agreements authorized by change order, extension, amendment or addendum for any increased funding under the terms of the previous section provided a copy of that action is also provided to the Finance Department.
