AN ORDINANCE APPROVING A REZONING FROM DISTRICT C-2 (GENERAL COMMERCIAL) TO DISTRICT C-3 (SERVICE COMMERCIAL) FOR THE PROPERTY AT 1311 E. US 24 HIGHWAY IN INDEPENDENCE, MISSOURI.

WHEREAS, an application submitted by Samuel Dyer III requesting approval of a rezoning from District C-2 (General Commercial) to District C-3 (Service Commercial) for property at 1311 E. US 24 Highway was referred to the Planning Commission as required by the Unified Development Ordinance; and,

WHEREAS, the Unified Development Ordinance provides for the approval of a rezoning following public hearings by the Planning Commission and City Council; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a public hearing for the consideration of the request on May 24, 2022, and rendered a report to the City Council recommending that the rezoning be approved by a vote of 6-0; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on June 21, 2022, and rendered a decision to approve the rezoning of the said property; and,

WHEREAS, in accordance with the Unified Development Ordinance, it was determined that the rezoning was consistent with the review criteria in Section 14-701-02; and,

WHEREAS, no legal protests were signed, acknowledged, and presented for the application.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the following legally described property is hereby rezoned from District C-2 (General Commercial) to District C-3 (Service Commercial) and shall be subject to the regulations of said district:

All that part of the Southeast Quarter of the Southwest Quarter of Section 36, Township 50, Range 32 in Independence, Jackson County, Missouri described as follows: Beginning 12 1/4 feet South of the Southwest corner of a certain tract of land conveyed by M. McD. Kidd to M. A. Hocker, dated May 30, 1896, of record in Book 209, Page 95, Recorder's Office, Jackson County, Missouri, at Independence, and running along the West line of said M. A. Hocker tract of land 412 1/2 feet to the South side of Lexington Boulevard nka U.S. Hwy 24; thence West 132 feet; thence South 412 1/2 feet; thence East 132 feet to the beginning, except that part in road.

SECTION 2. Nonseverability. All provisions of this ordinance are so essentially, and inseparable connected with, and so dependent upon, each other that no such provision would be enacted without all others. If a court of competent jurisdiction enters a final judgement on the merits that is not subject to appeal and that declares any provision or part of this ordinance void, unconstitutional, or unenforceable, then this ordinance, in its collective entirety, is invalid and shall have no legal effect as of the date of such judgement.
