A RESOLUTION AUTHORIZING THE FILING OF APPLICATION(S) WITH THE MISSOURI DEPARTMENT OF NATURAL RESOURCES, FINANCIAL ASSISTANCE CENTER'S STATE ARPA GRANT PROGRAMS FOR SUBAWARD OF FEDERAL FINANCIAL ASSISTANCE PROVIDED TO THE STATE OF MISSOURI BY THE U.S. DEPARTMENT OF THE TREASURY PURSUANT TO SECTION 602(B) OF THE SOCIAL SECURITY, AS ADDED BY SECTION 9901 OF THE AMERICAN RESCUE PLAN ACT, (PUB. L. NO. 117-2 (MARCH 11, 2021), 135 STAT. 4, 223-26.

WHEREAS, under the terms of section 602(c) of the Act and Treasury's regulations, the State of Missouri has authorized the making of grants to authorized applicants to aid in the completion of specific public projects, and,

WHEREAS, various storm water improvement projects, sanitary sewer improvement projects, Rock Creek Treatment Plant upgrade projects, and water department projects are eligible for this funding; and,

WHEREAS, the City is eligible for said grants from a minimum of 1(One) dollar price matching to a maximum of 20 (twenty) percent of price matching on projects; and,

WHEREAS, the City recognizes the importance of installing water and sewer infrastructure in newly developed areas, as well as the necessity to make repairs to dated and failing infrastructure;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

<u>SECTION 1</u>. The Independence City Council supports the submittal of a grant application(s) to seek funds to assist with water projects.

<u>SECTION 2</u>. That Lisa Reynolds, Director of Municipal Services, be and is hereby authorized to execute and file an application(s) on behalf of the City of Independence, Missouri with the State of Missouri for grant funding to aid in the completion of various water projects throughout the City.

SECTION 3. That Lisa Reynolds, Director of Municipal Services, is hereby authorized and directed to furnish such information as the Missouri Department of Natural Resources may reasonably request in connection with the application(s) which is herein authorized, to sign all necessary documents on behalf of the applicant, to furnish such assurances to the Missouri Department of Natural Resources as may be required by law or regulation, and to receive payment on behalf of the applicant.
