2023 Pharmacy Analysis



- Initial Savings Projection: \$400,000 \$500,000 (based on analysis from 2021)
- Updated Savings Projection: > \$700,000
 - Move to CVS Caremark through the Employer's Health Pharmacy Coalition, using the PrudentRx specialty Rx management program
- Proceeding with this option will result in breaking of the multi-year contract with Cigna, which would incur financial penalties. Those penalties have been accounted for in the CBIZ projections.
 - Penalties include:
 - \$1.50 PMPM fee through the end of the Cigna contract (12/31/24) payable up front
 - \$128,000 wellness fund clawback
 - > \$12 PEPM PBM carveout fee (paid with monthly admin fee)

Additional comments:

- Up tier/down tier apply to the OAP 1 members, and means the copay goes up or down within the existing plan design.
- OAP 2 and LP members are subject to their deductible before coinsurance applies, so drug prices are dependent on the chosen pharmacy, and even by the day. Consumerism and using apps like GoodRx or the CVS Caremark app help members navigate the best price for drugs while they are subject to the deductible.
- Any members impacted by a tier/formulary change or exclusion will receive a personalized letter from CVS indicating which of their drugs will have a change, what the impact is, and a solution to discuss with their provider. Letters will be mailed 30-60 days before go-live.
