





LEASE

This Lease is made between Noland Real Estate LLC ("Lessor"), and Noland Petroleum LLC, ("Tenant"). Tenant hereby offers to lease from Lessor the real property located in the City of Independence, State of Missouri, with a common address of 3900 S. Noland Road, Independence, Missouri 64055, (the "Real Property"), upon the following terms and conditions. (This document shall hereafter be referred to as the "Lease").

TERMS AND CONDITIONS

- 1. Term and Rent. Lessor leases to Lessee the above Real Property for a term of 5 years, commencing July 1,2022 and terminating on June 30, 2027, or sooner as provided herein at an annual rent of Twelve Thousand Dollars \$12,000.00 payable in advance on the first day of each month for that month's rental, during the term of this Lease.
- 2. Option to Renew. Provided that Tenant is not in default in the performance of this Lease, Tenant shall have the option to renew the Lease for additional terms on a month to month basis commencing at the expiration of the initial Lease term. All of the terms and conditions of the Lease shall apply during the term of the lease.
- 3. Use. Tenant shall use and occupy the Real Property for the commercial purpose of Liquor, tobacco and merchandise sales. The Real Property shall be used for no other purpose.
- 4. Care and Maintenance of Real Property. Tenant acknowledges that the Real Property is in good order and repair, unless otherwise indicated herein. Tenant shall, at his own expense and at all times, maintain the Real Property in good and safe condition, including plate glass, electrical wiring, plumbing and heating installations and any other system or equipment upon the Real Property and shall surrender the same, at termination hereof, in as good condition as received, normal wear and tear excepted.
- 5. Ordinances and Statutes. Tenant shall comply with all statutes, ordinances, regulations, covenants, conditions and requirements of all municipal, state and federal authorities (including owner's association and similar entities) now in force, or which may hereafter be in force, pertaining to the Real Property, occasioned by or affecting the use thereof by Tenant.
- 6. Utilities. All applications and connections for necessary utility services on the Real Property shall be made in the name of Tenant only, and Tenant shall be solely liable for utility charges as they become due, including those for sewer, water, gas, electricity, and telephone services.
- 7. Indemnification of Lessor. Tenant shall not be entitled to any part of the award for such taking or any payment in lieu thereof, but Tenant may file a claim for any taking of fixtures and improvements owned by Tenant, and for moving expenses.

- 10. Destruction of Real Property. PURCHASE AGREEMENT

Section 4. Due Diligence

Buyer shall have the right, prior to Closing and delivery of possession, to enter upon the Property, at all reasonable times, for the purpose of making whatever examinations, surveys, studies or tests Buyer desires to make, in Buyer's sole discretion, for the purpose of determining the suitability of the Property for Buyer's purposes and to show the Property to prospective lenders, tenants or other interested persons.
