

RESOLUTION BILL NO. 98-758

RESOLUTION NO. 4530

A RESOLUTION CREATING A SEVEN MEMBER STREET IMPROVEMENTS OVERSIGHT COMMITTEE, DEFINING THE PURPOSES AND DUTIES OF THE COMMITTEE; AND PROVIDING FOR ITS ORGANIZATION AND PLAN OF OPERATION.

WHEREAS, the Independence City Council has determined it to be in the best interest of the City to have a citizen body to monitor expenditure of proceeds from the Capital Improvements Sales Tax that are dedicated for street improvements;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That there is hereby created a Street Improvements Oversight Committee to be composed of seven individuals who are residents of the City of Independence and are interested in promoting public education regarding street projects, and appropriate expenditure of the City's Capital Improvements Sales Tax.

SECTION 2. That the Street Improvement Oversight Committee will consist of seven members, with each Councilmember appointing one member. Each member will serve without compensation.


A. Although the terms of appointment are to be for three years, persons first appointed to the Street Improvements Oversight Committee shall serve staggered terms as follows:

SECTION 3. That the Committee shall meet at least quarterly to review collection and expenditure of revenue from the Capital Improvements Sales Tax, and progress toward completion of street improvement projects funded therefrom, and shall make a written, public status report in April and October of each year.


SECTION 4. That the City Manager will designate appropriate City staff to service as liaison to the Street Improvements Oversight Committee.



RESOLUTION NO. 4822

A RESOLUTION AMENDING SECTION 2 OF RESOLUTION NO. 4530 TO ALLOW A PERSON TO SERVE ON THE STREET IMPROVEMENTS OVERSIGHT COMMITTEE WHO IS ALSO SERVING ON ANOTHER CITY COUNCIL APPOINTED BOARD, COMMISSION OR COMMITTEE.

WHEREAS, it has been determined appropriate to allow for a person who is serving on another City Council appointed Board, Commission or Committee to also serve on the Street Improvements Oversight Committee;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That Section 2 of Resolution No. 4530 be and is hereby amended to read as follows:


"SECTION 2. That the Street Improvement Oversight Committee will consist of seven members, with each Councilmember appointing one member. Each member will serve without compensation. It will be permissible for a person to serve on this Committee who is also serving on another City Council appointed Board, Commission or Committee.

A. Although the terms of appointment are to be for three years, persons first appointed to the Street Improvements Oversight Committee shall serve staggered terms as follows:





RESOLUTION NO. 4889

A RESOLUTION AMENDING SECTION 1 OF RESOLUTION NO. 4530 TO ENSURE THAT THE STREET IMPROVEMENT OVERSIGHT COMMITTEE SHALL CONTINUE TO PERFORM ITS ESSENTIAL DUTIES IRRESPECTIVE OF WHETHER THE STREET IMPROVEMENT FUNDING MECHANISM IS THE CAPITAL IMPROVEMENTS SALES TAX, TRANSPORTATION IMPROVEMENT SALE TAX OR OTHER SIMILAR SALES TAX.

WHEREAS, the Independence City Council has determined it to be in the best interest of the City to have a citizen body to monitor expenditure of proceeds from all sources of sales taxes that are dedicated for street improvements;


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That Section 1 of Resolution No. 4530 be and is hereby amended to read as follows:

"SECTION 1. That there is hereby created a Street Improvements Oversight Committee to be composed of seven individuals who are residents of the City of Independence and are interested in promoting public education regarding street projects, and appropriate expenditure of the City's Capital Improvements Sales Tax, Transportation Improvement Sales Tax or any other sales tax adopted for the benefit of street improvements as approved by the voters."






