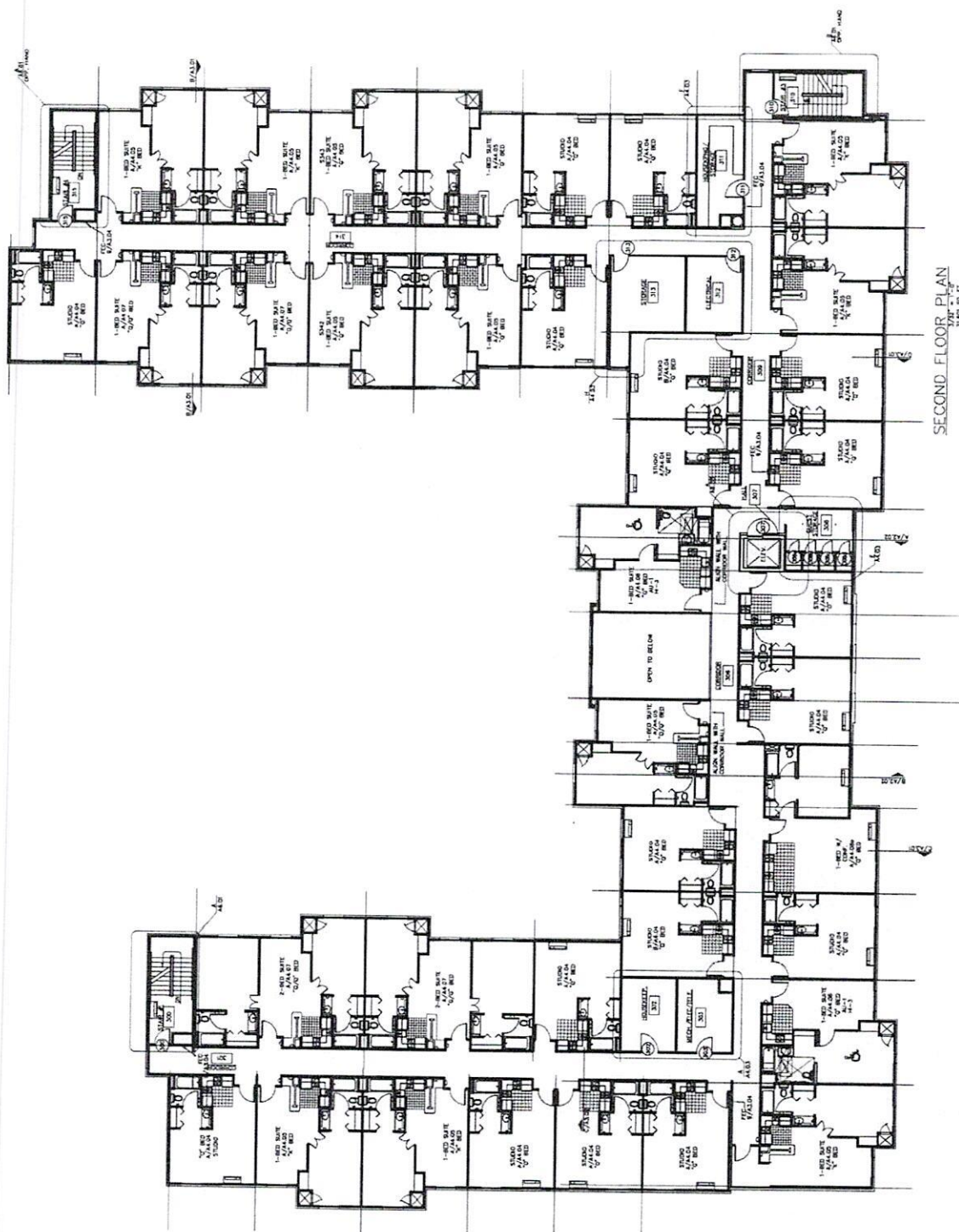






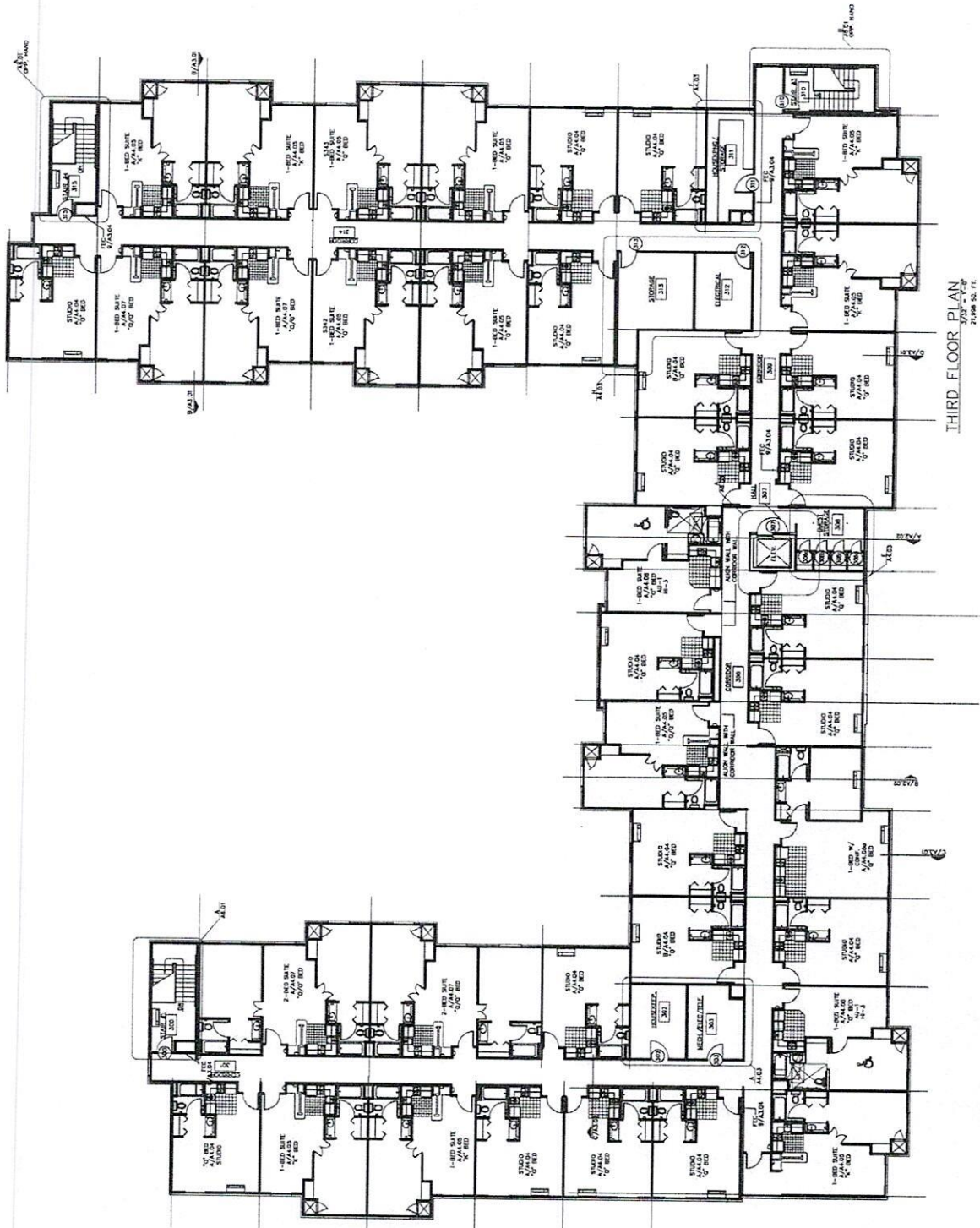






SECOND FLOOR PLAN

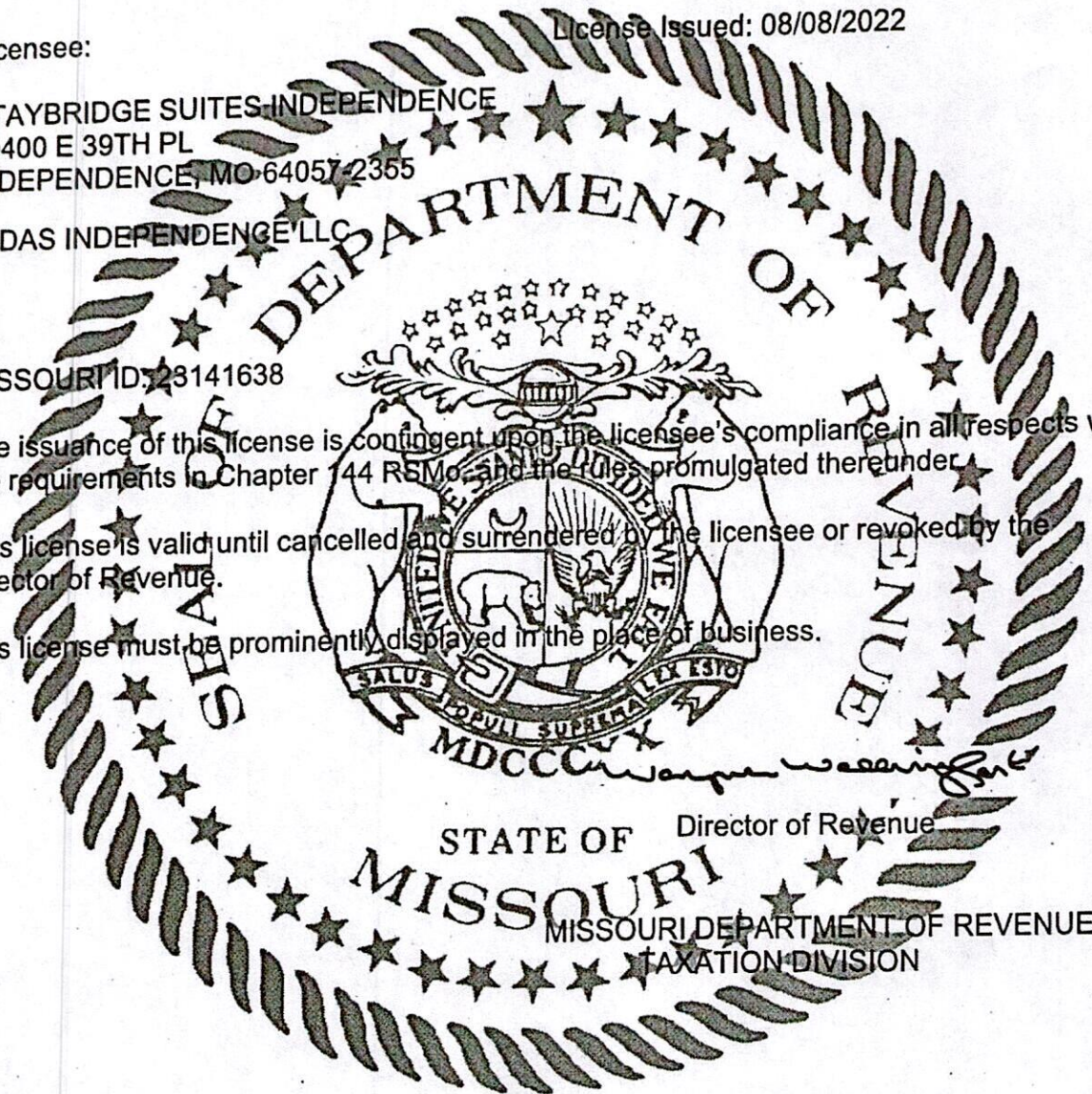


