AN ORDINANCE AUTHORIZING THE PURCHASE OF TWO (2) NEW SPARTAN CUSTOM 4-DOOR PUMPER FIRE TRUCKS FROM PRECISION INDUSTRIES INC. FOR \$1,440,876.01 AND MAKING THE NECESSARY APPROPRIATIONS.
WHEREAS, Precision Industries is a Missouri based area dealer for Fire Department vehicles and trucks; and,
WHEREAS, Precision Industries is offering to the City a two (2) Spartan custom 4-door pumper fire trucks; and,
WHEREAS, in order to freeze the chassis cost before additional increases occur, it is necessary to pay for the cost of the chassis in fiscal year 2022-2023; and,
WHEREAS, the Chief of the Fire Department recommends the execution of a purchase order to Precision Industries;
NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:
SECTION 1. That the City Manager of the City of Independence, Missouri, shall be and is hereby authorized and directed to sign and execute for and on behalf of said City a purchase order with Precision Industries providing for the purchase of two (2) Spartan custom 4-door pumper fire trucks for a sum not to exceed One Million Four Hundred Forty Thousand Eight Hundred Seventy-Six Dollars and 01/100 (\$1,440,876.01).
<u>SECTION 2.</u> That Council hereby appropriates the sum of One Million Four Hundred Forty Thousand Eight Hundred Seventy-Six Dollars and 01/100 (\$1,440,876.01) for payment of this purchase from the Public Safety Sales Tax Fund.
SECTION 3. That Council acknowledges that the sum of Seven Hundred Ninety Thousand Eight Hundred Seventy-Six Dollars (\$790,876.00) will be expended in fiscal year 2022-2023 for payment of the expenses associated with the chassis' purchase, to avoid any subsequent increase in cost.
SECTION 4. That Council acknowledges that the remaining balance in the sum of Six Hundred Fifty Thousand Dollars and 01/100 (\$650,000.01) shall be paid upon delivery of the vehicles on August 31, 2024.
