The Fiscal Year 2023 budget was submitted to the City for review on March 17, 2022 and was adopted via Resolution 2022-05 on May 23, 2022.

WHEREAS, the Board of Directors of the District desires to purchase insurance to provide coverage for general liability, errors and omissions, and other risks; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE INDEPENDENCE SQUARE COMMUNITY IMPROVEMENT DISTRICT, AS FOLLOWS:

- 1. The Policy of Directors Liability Insurance attached to this Resolution as **Exhibit A** is hereby authorized and approved.
- 2. The officers of the District and General Legal Counsel for the District are authorized to take such further actions as are necessary to obtain a Policy of Directors Liability Insurance as authorized in this Resolution.
- 3. The officers of the District and General Legal Counsel for the District are authorized to take such actions as are necessary to annually renew the general liability and errors and omissions insurance policy.
- 4. In the event the District has no funds with which to pay the premium for the Policy of Directors Liability Insurance, the District authorizes the Independence Square Main Street Corporation ("ISMS") to pay such costs as an administrative expense, to be reimbursed to ISMS from proceeds of the District sales tax upon collection thereof.
- 5. This Resolution shall take effect immediately upon its execution.

#### **Budget Message**

The Independence Square Community Improvement District (the "District") was formed as a political subdivision of the State of Missouri on August 3, 2020 by virtue of an ordinance approved by the City Council of Independence, Missouri. The stated purpose of the District is to provide funding for public improvements within the District. The District adopted a fiscal year from July 1 to June 30.

### **Important Budget Features**

The District's source of revenue is anticipated to initially be a 1% Community Improvement District Sales Tax, a special purpose tax levied pursuant to the Missouri Community Improvement District Act, Sections 67.1401 to 67.1571 of the Missouri statutes.

#### **Important Changes from Previous Fiscal Year**

The District imposed its sales tax at the beginning of Fiscal Year 2022. This budget reflects the first full fiscal year of revenues for the District.
