Dear Valued Customer,

We appreciate the opportunity to continue to respond to your control system needs with a GE OEM control system platform of GE parts/solutions, GE trained Application Engineers, and support of your installation/commissioning activities by GE trained Nexus Controls Field Application Engineers.

Nexus Controls, a Baker Hughes business was formerly called Control Solutions when organized under GE Oil & Gas. As the controls retrofit Center of Excellence for GE Oil & Gas we were named and continue to be the control system upgrade business for GE Power Services. Shortly after GE announced their intent to sell several of their businesses, including GE Oil & Gas, we started working to develop a formal agreement that would govern the relationship and customer responsibilities after separation. The result of this effort was the "GE/Baker Hughes Channel Agreement" which was finalized/signed on July 3, 2017. The "GE/Baker Hughes Channel Agreement" is valid until October 2023.

Nexus Controls will be responsible for the first 12 to 18 months of the warranty on any GE control system upgrade we perform. Upon expiration of the Nexus Controls warranty the service and support of the GE hardware/software reverts back to GE unless we sign a Service Agreement with your business.

Ladies and Gentlemen:

This agreement (this "**Agreement**") is entered into as of July 3, 2017, by and between GENERAL ELECTRIC COMPANY, a New York corporation ("**GE**"), and BAKER HUGHES, A GE COMPANY, a Delaware corporation ("**Newco**" and, together with GE, the "**Channel Partners**");

c. For the sale of technological upgrades and spare parts for the Mark VIe integrated control, protection and monitoring system for generator and mechanical drive applications of gas and steam turbines and its prior models (collectively, the "**Legacy Mark VIe**") (the "**Mark VIe Controls Products Upgrade Channel**"), the responsibility for performing as the Leading Party shall be in accordance with Schedule C;

SCHEDULE C


Mark VIe Control Products Upgrade Channel

Except as otherwise provided below, Newco shall continue to be the Leading Party with respect to Legacy Mark VIe turbine upgrades sold by O&G to GE Power customers:

1. Newco (through Control Solutions) shall continue to be the Leading Party with respect to performing controls only upgrades on the GE manufactured turbine fleet
