Jackson County Shrine Club (JCSC) is a private, charitable fraternal organization chartered by the Ararat Shrine of Kansas City, Mo. JCSC has been a fixture in Independence Missouri since it's incorporation in 1945.

Over the years many local community leaders have been members of Jackson County Shrine Club. We have participated in or sponsored hundreds of community events, parades, old folks dances, kids parties. We have helped many kids regain their health through support of the Shrine Hospital system.

In 1956 the Jackson County Shrine Club bought property and built a club building at 120 ½ S Pleasant Independence, Mo where it still resides.

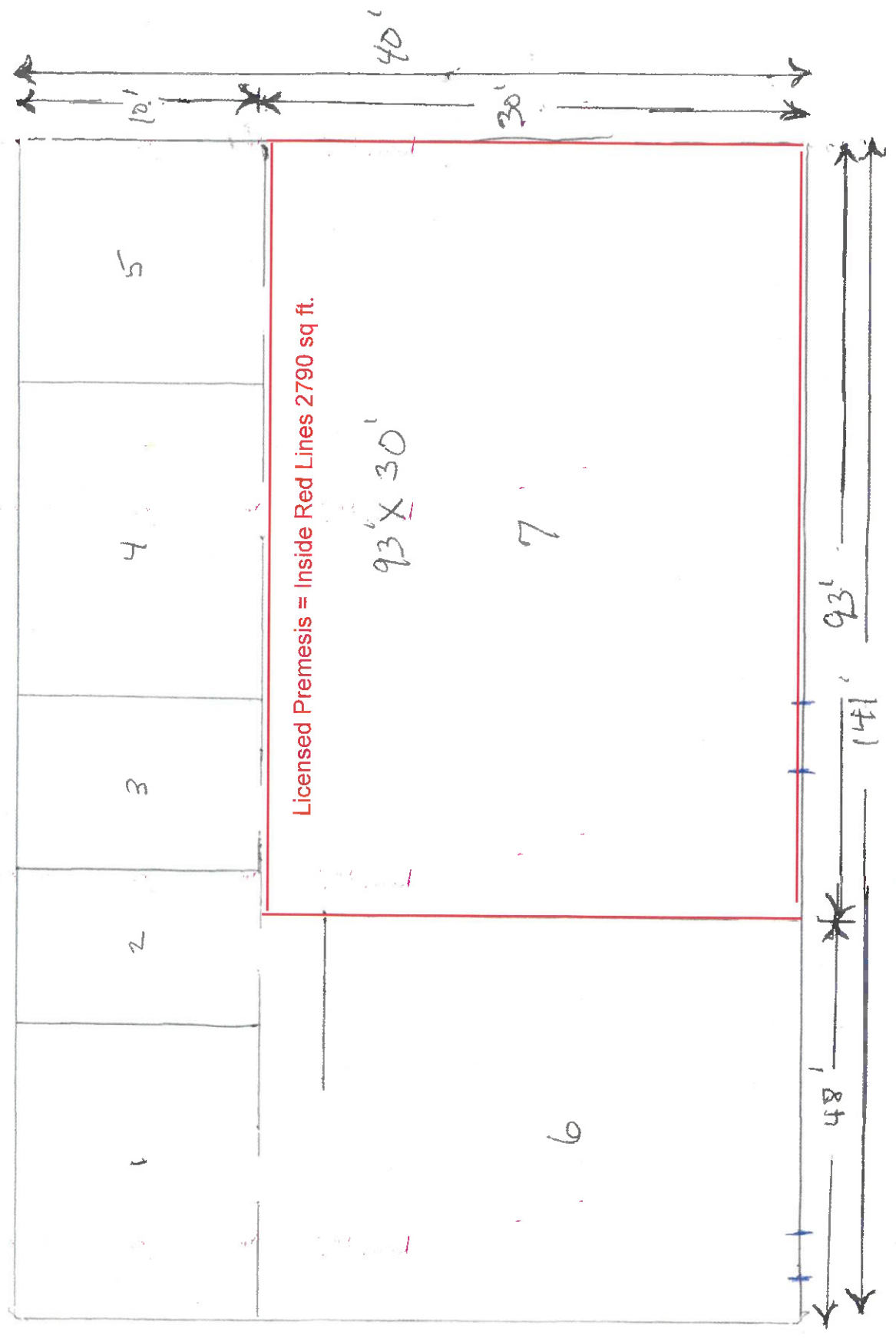

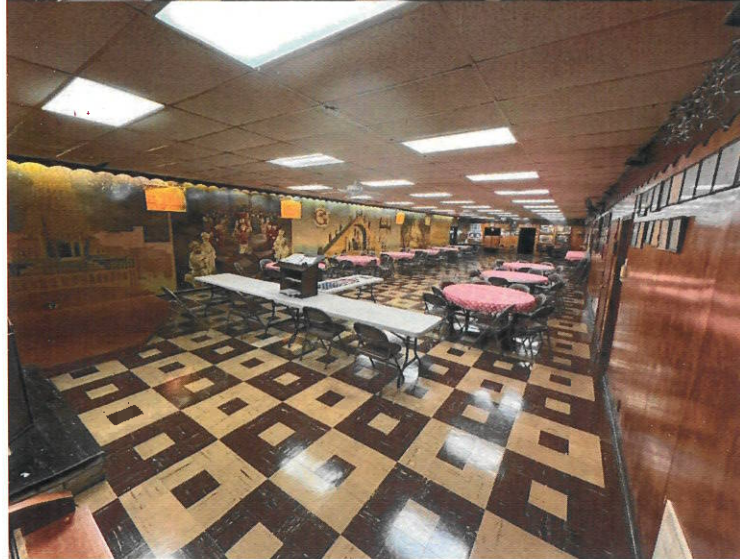

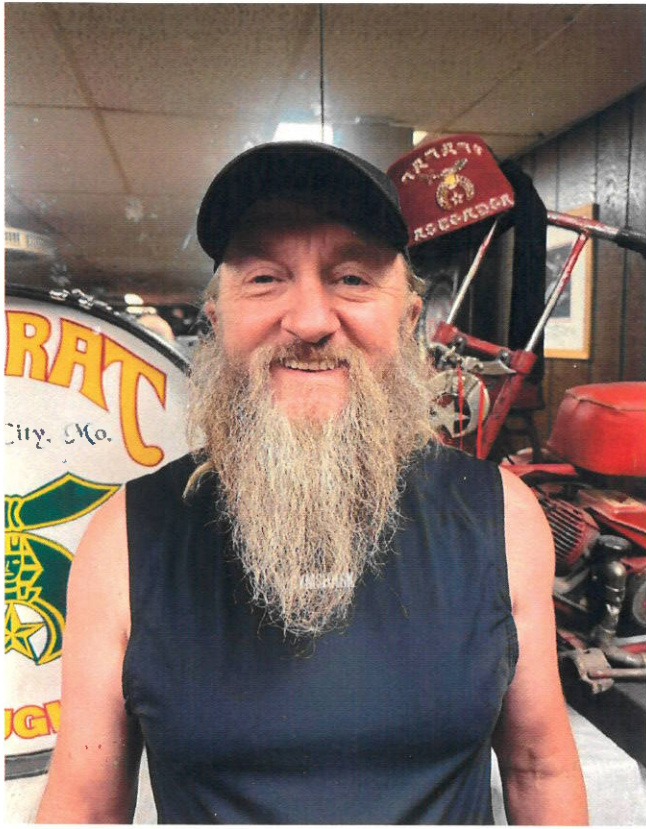
