To Whom It May Concern,

QuikTrip currently owns and is developing the property at 16813 E. 23<sup>rd</sup> St. S in Independence, Missouri. We are constructing a 5,312 square foot convenience store building on this site, and respectfully request approval of our liquor license application for P1 (Retail Selling of Intoxicating Liquor of all kinds in the original package) and S (Sunday Sales) sales.

QuikTrip is requesting a Liquor License in order to sell packaged spirits from our proposed convenience store. The majority of items offered inside the convenience store include food items – both packaged and prepared from the kitchen – as well as non-alcoholic beverages and other convenience items. Packaged beer, wine, and liquor items comprise approximately 5% or less of the store's building footprint, accounting for 200 – 300 square feet of storage out of 5,312 square feet total.

This store will employ dozens of individuals, and the number of staff present varies depending on demand. However, we expect that during the day there will be anywhere from 1-10 employees on site at any given time. Although this QuikTrip store will be open 24 hours a day, 7 days a week, liquor sales hours are in accordance with Missouri and Independence law from 6:00 a.m. to 1:30 a.m. daily.

The stores do not allow for alcoholic beverage drinking on site, although we are proposing two tables on the patio outside the store. These tables are proposed to allow for patrons to enjoy their non-alcoholic QuikTrip purchases.

QuikTrip has a demonstrated record of our ability and commitment to act as a reliable and capable retailer. We have strict Responsible Retailing policies in place to help ensure compliance with all liquor laws, and we also conduct internal compliance shops.






