# PURCHASE AND SALE AGREEMENT

THIS PURCHASE AND SALE AGREEMENT ("Agreement") is made this 24<sup>th</sup> day of January, 2023 ("Effective Date") by and between Minit Mart LLC, a Delaware limited liability company, with an address for purposes of notice hereunder of c/o EG America LLC, 165 Flanders Road, Westborough, Massachusetts 01581, Attention: Nick Unkovic (hereinafter referred to as "Seller") and Casey's Retail Company and Casey's Marketing Company, both Iowa corporations with principal offices in Ankeny, Polk County, Iowa (hereinafter referred to as "Casey's");

# WITNESSETH: Washington Administration

WHEREAS, Seller currently operates convenience stores and fuel filling stations located at the sites described on <a href="Exhibit A">Exhibit A</a>, attached hereto and incorporated herein (the "Business");

WHEREAS, the Business assets include twenty-six (26) sites for which the Seller owns the underlying real estate, the street addresses and legal descriptions of which are listed and described on Exhibit A (the "Real Estate" and together with the improvements thereon, the "Stores"); and

WHEREAS, the parties have reached an understanding and agreement that, subject to the satisfaction of certain conditions and contingencies as hereinafter provided, Seller will sell and Casey's will purchase all of Seller's right, title and interest in and to the Stores, including the inventory, supplies, and other personal property (except cash and receivables) kept or used in connection with the operation of the Business at the Stores, all upon the terms and conditions contained in this Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants hereinafter set forth, the parties agree as follows:

Assets Conveyed. Seller shall sell and Casey's shall purchase, in multiple closings 1. as further described herein, all of Seller's right, title and interest in and to only the following assets: (A) the Real Estate, (B) to the extent owned by Seller, the buildings and other improvements, together with all permanently attached machinery, fixtures, heating, plumbing, electrical, lighting, ventilating, and air-conditioning equipment (the "Improvements") affixed to or located at the Stores, subject to any right of a counterparty under any Assumed Contract (as hereinafter defined) applicable to the Real Estate, (C) the contracts listed on Exhibit B, attached hereto and incorporated herein (the "Assumed Contracts"), and (D) all merchantable stock-in-trade inventory, Equipment, supplies and other personal property owned by Seller, in each case, located at the Stores used solely in connection with the Business and subject to the rights of any counterparty under any Assumed Contract (Subsections (A) through and including (D) are collectively, the "Assets"). Without limitation, the Assets shall not include cash or receivables (other than cash included in inventory pursuant to Section 13 (Purchase of Inventory)), any equipment owned by Phillips 66 Company, any Intellectual Property, any of Seller's permits or licenses, any items listed on Exhibit C, attached hereto and incorporated herein or any assets of Seller not specifically included in the definition of Assets. The Assets shall include all tangible personal property owned by Seller and used solely in connection with the operation of and located at the Stores, including, without limitation, furniture, fixtures, shelving, display racks, walk-in coolers, furnishings, canopies,
