I understand Short-Term Rentals are prohibited form hosting weddings, banquets, parties, charitable fundraisers, or other similar gatherings.

I understand a Short-Term Rental shall not be rented to more than one (1) booking party at a time.

I understand I shall not live in the unit when the unit is rented.

I understand I am prohibited from providing food, light snacks, or other food and/or meals to guest(s).

I understand I shall maintain liability insurance appropriate to cover the Short-Term Rental use in the aggregate of not less than \$1,000,000 or conduct each Short-Term Rental transaction through a platform that provides equal or greater insurance coverage.

I understand Short-Term Rental permits are not transferable to another operator, owner or location.

I understand I shall post in a prominent location of the dwelling the City's Good Neighbor Guidelines, the maximum permitted occupancy of the Short-Term Rental, evacuation plan, parking plan, trash disposal requirements, responsible agent name and contact information, the street address of the Short-Term Rental and the Short-Term Rental license number.


I understand I'm required to obtain a Rental Ready Inspection prior to renewal of the annual business license.




