Mayor Rowland stated that this process has been very complicated, and lot of time has been spent on this ethics reform update. Mayor Rowland stated that he will be voting no on this amendment. Councilmember Steinmeyer stated that he was against the last extension and stated that the Mayor advised that committee should be able to get this handled by the end of March and he still has not

been given the updated 30 pages that the committee has worked on to this point. Councilmember Steinmeyer stated that he agrees ethics in politics is necessary, but how we go about it should involve the Council. Councilmember Steinmeyer stated that August 15th will give the committee a full year but doesn't like the idea of continuing to move it down the road. Councilmember McCandless stated that she believes some of the pressure is on this Council to make decisions and work with the Ethics Commission and to help keep this moving along she is comfortable with the August 15th date.
