The Independence City Council met for a Special Called Meeting, May 22, 2023, at 7:13 p.m., in the Council Chambers, 111 E. Maple.

CITIZENS REQUEST TO SPEAK:

Councilmembers Stewart and Fears moved to suspend the Rules of Procedure to allow for non-residents to speak during Citizen Request.

Upon roll call, the vote was: Ayes –Councilmembers: Fears, Perkins, Stewart, McCandless, Steinmeyer, Hobart and Mayor Rowland. Noes – None. Absent – None. The Mayor declared the motion approved.

Jack Layman spoke to Council regarding trees on Lee's Summit Road.

At 7:20 p.m., Mayor Rowland called for a short recess to correct sound issues. The meeting was called back to order at 7:21 p.m.

ORDINANCES:

Bill No. 23-037, entitled, [failed]

"AN ORDINANCE SUBMITTING TO THE REGISTERED QUALIFIED VOTERS OF THE CITY OF INDEPENDENCE AN ORDINANCE PROPOSING A REPEAL OF INDEPENDENCE CITY CODE OF ORDINANCES SECTION 3.03.006 "KEEPING OF PIT BULLS PROHIBITED" AND A REVIEW OF INDEPENDENCE CITY CODE OF ORDINANCES SECTIONS 3.03.007 "AGGRESSIVE DOGS," 3.03.008 "DANGEROUS DOGS," AND 3.03.009 "VICIOUS DOGS," TO ASSURE PROTECTIONS FOR THE CITIZENS FROM ANY DANGEROUS ANIMALS."

was given its second reading by title and placed on final passage. Councilmember Fears shared his feelings regarding breed specific legislation and next steps he would like to see updated in the dangerous ordinance and City Code. Councilmember Stewart shared his feelings regarding breed specific legislation and shared why he will vote for this to go to a ballot. Councilmember McCandless shared some of her research on this topic and her feelings regarding breed specific legislation. Councilmember Steinmeyer shared his feelings regarding breed specific legislation and why he will be voting to send this item to the voters. Councilmember Hobart shared his feelings regarding breed specific legislation and stated he will be voting against sending this to a public vote and in two weeks he will vote to overturn the ban and ask for a 60 day stay on the repeal of the ban for updates Council would like to see in the City Code. Mayor Rowland shared his feelings regarding breed specific legislation and why he will vote to repeal the ban and why he will vote no to send this issue to a ballot.

Upon roll call, the vote was: Ayes –Councilmembers: Stewart and Steinmeyer. Noes – Councilmembers: Fears, Perkins, McCandless, Hobart and Mayor Rowland. Absent – None. The Mayor declared the bill failed.
