A RESOLUTION AMENDING THE TERMS OF THE MEMBERS OF THE CITY CHARTER REVIEW COMMISSION.

WHEREAS, Resolution 6846 was approved by the City Council on August 1, 2022, creating the City Charter Review Commission; and

WHEREAS, Resolution 6867 was approved on October 17, 2022 which amended Resolution 6846 by redefining how members of the City Charter Review Commission would be selected; and

WHEREAS, Resolution 6877 was approved on December 5, 2022 appointing members to the Charter Review Commission; and

WHEREAS, Resolution 6884 was approved on January 3, 2023, amending Resolution 6867 by expanding the City Charter Review Commission from nine to eleven members; and,

WHEREAS, Resolution was approved on February 20th, 2023, which appointed the final two members of the City Charter Review Commission; and,

WHEREAS, the City Charter Review Commission held its first meeting on February 6th, 2023; and,

WHEREAS, the City Charter Review Commission has been meeting bimonthly and has thoughtfully and deliberatively conducted an Article by Article review of the City Charter; and,

WHEREAS, due to several circumstances, including the length of the current City Charter, the elapsed time since the last City Charter review was conducted, and the late start granted to the City Charter Review Commission, this group has not yet completed their review and prepared their recommendations for presentation to the City Council; and,

WHEREAS, the terms for all eleven members of the City Charter Review Commission expire on August 1, 2023; and,

WHEREAS, it is advisable to extend these terms in order to complete this critical process;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1: That the City Council of the City of Independence, Missouri hereby appoints the following individuals to the Charter Review Commission, to serve without compensation for the indicated term or until duly succeeded by another person properly appointed and qualified:
