AN ORDINANCE APPROVING A REZONING FROM DISTRICT C-1 (NEIGHBORHOOD COMMERCIAL) TO DISTRICT C-2 (GENERAL COMMERCIAL) FOR THE PROPERTY AT 2500 N. LIBERTY STREET IN INDEPENDENCE, MISSOURI.

WHEREAS, an application submitted by Lindsay Vogt requesting approval of a rezoning from District C-1 (Neighborhood Commercial) to District C-2 (General Commercial) for the property at 2500 N. Liberty Street referred to the Planning Commission as required by the Unified Development Ordinance; and.

WHEREAS, the Unified Development Ordinance provides for the approval of a rezoning following public hearings by the Planning Commission and City Council; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a public hearing for the consideration of the request on October 10, 2023, and rendered a report to the City Council; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on November 20, 2023, and rendered a decision to approve the rezoning of the said property; and,

WHEREAS, in accordance with the Unified Development Ordinance, it was determined that the rezoning was consistent with the review criteria in Section 14-701-02; and,

WHEREAS, no legal protests were signed, acknowledged, and presented for the application.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

<u>SECTION 1.</u> That the following legally described properties are hereby rezoned from District C-1 (Neighborhood Commercial) to C-2 (General Commercial) and shall be subject to the regulations of said district:

1. KENTUCKY HILLS; LOT 1 AND PT LOT 3 FRED KLEEVER PLACE DAF: BEG MOST SLY COR; LOT 3 TH N ALG E LI 59' TH W 28.95' TH SE 67.09 TO POB AND LESS PT OF KENTUCKY HILLS LOT 1 BEG NW CON LOT 1 TH S 25 DEG 41 MIN 20 SEC E ALG N LN OF LOT 1 190.79', TN S 85 DEG 40 MIN 32 SEC W TO THE W LN OF LOT 1 92.06', TN ALG W LN OF LOT 1, N 02 DEG- 45 MIN 09 SEC E 178.83' TO POB.

SECTION 2. Nonseverability. All provisions of this ordinance are so essentially, and inseparable connected with, and so dependent upon, each other that no such provision would be enacted without all others. If a court of competent jurisdiction enters a final judgement on the merits that is not subject to appeal and that declares any provision or part of this ordinance void, unconstitutional, or unenforceable, then this ordinance, in its collective entirety, is invalid and shall have no legal effect as of the date of such judgement.
