AN ORDINANCE AUTHORIZING A CONTRACT WITH AXON FOR BODY WORN CAMERAS, IN-CAR VIDEO, TASERS, VIRTUAL REALITY TRAINING AND EQUIPMENT, TRANSCRIPTION AND REDACTION SERVICES, ADMINISTRATIVE AND CRIMINAL INVESTIGATIVE SOFTWARE, UNLIMITED CLOUD STORAGE AND RECORDS FULFILLMENT SERVICES FOR \$12,399,492.25; AUTHORIZING FUTURE CHANGE ORDERS NOT TO EXCEED \$1,239,949.23, AS DEEMED APPROPRIATE; AND APPROPRIATING \$908,798.03 FROM THE USE TAX FUND ASSETS.

WHEREAS, the Chief of Police Department of Independence, Missouri, finds it necessary to replace in-car video equipment, tasers and records management software for the Police Department; and

WHEREAS, the Chief of the Police Department recommends the execution of a purchase order and ten-year contract to Axon Enterprise Incorporated; and

WHEREAS, Axon Enterprise Incorporated, a national public safety products provider is offering body worn cameras, in-car video, tasers virtual reality training and equipment, transcription and redaction services, administrative and criminal investigative software, unlimited cloud storage and records fulfillment services through a national cooperative procurement contract; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF INDEPENDENCE, MISSOURI, AS FOLLOWS:

SECTION 1. That the City Manager of the City of Independence, Missouri, shall be and is hereby authorized and directed to sign and execute for and on behalf of said City expenditures with Axon Enterprise Incorporated providing for body worn cameras, in-car video, tasers virtual reality training and equipment, transcription and redaction services, administrative and criminal investigative software, unlimited cloud storage and records fulfillment services a sum of One Million, Four-Hundred Fifty Six Thousand, Six Hundred Fifty-Four Dollars and Ninety-Six Cents (\$1,456,654.96), and to authorize additional funding of One Hundred Forty-Five Thousand, Six Hundred Sixty-Five Dollars and Fifty Cents (\$145,665.50) for minor changes orders if deemed necessary.

<u>SECTION 2</u>. That the City Manager is authorized to appropriate Nine Hundred Eight Thousand Seven Hundred Ninety-Eight Dollars and Three Cents (\$908,798.03) from the Use Tax Fund Balance to cover the initial cost for this initiative.

Body-Worn Cameras, Tasers, In-Car Video, Virtual Reality Training and Equipment, Transcription and Redaction Services, Administrative and Criminal Investigative Software, Unlimited Cloud Storage and Record Fulfillment Services.

SECTION 3. That the City Manager of the City of Independence, Missouri, shall be and is hereby authorized and directed to sign and execute for and on behalf of said City expenditures with Axon Enterprise Incorporated providing for body worn cameras, in-car video, tasers virtual reality training and equipment, transcription and redaction services, administrative and criminal investigative software, unlimited cloud storage and records fulfillment services a sum of One Million, Two-Hundred Fifteen Thousand, Eight-Hundred Seventy Dollars and Eighty-One Cents (\$1,215,870.81), and to authorize additional funding of One-Hundred Twenty One Thousand Five-Hundred Eighty-Seven Dollars and Eight Cents (\$121,587.08) for minor changes orders if deemed necessary for nine (9) more additional fiscal years.

SECTION 4. The City Manager requests that the Management Analyst review be waived. The contract for body worn cameras, in-car video, tasers virtual reality training and equipment, transcription and redaction services, administrative and criminal investigative software, unlimited cloud storage and records fulfillment services qualifies for review by the City's Management Analyst pursuant to Sec. 6 of the City's Procurement Policy and City Code Sec. 1.43.007.D. Because the Management Analyst position is currently vacant, the Council, by approval of this ordinance, hereby waives review of this contract.
